## Delta Dental of Oklahoma Receives the OU College of Dentistry 2007 Distinguished Service Award

On behalf of Delta Dental of Oklahoma and its Charitable Foundation, Mr. John Gladden, President & CEO of Delta Dental of Oklahoma, recently accepted the OU College of Dentistry's 2007 Distinguished Service Award.

As part of the criteria for receiving the award, the candidate must have made significant contributions to the OU College of Dentistry (or directly to the OUCOD Alumni Association) through one or more notable activities that include the following:

- Significant support of the Alumni Association's mission/projects
- Active involvement in alumni affairs
- Long-term sponsorship of College and/or Association activities
- Major gifts to the College (donations, scholarships, etc.)

Delta Dental of Oklahoma received a unanimous vote from OUCOD Alumni Association Executive Committee members at the selection meeting.

"When Delta Dental of Oklahoma was proposed to the Alumni Association Executive Committee as a nominee for this award, there was no need for discussion," said Dr. Frank J. Miranda, Associate Dean for Alumni Affairs. "Every committee member knew Delta Dental of Oklahoma well and acknowledged the company's long and storied history of support for dentistry. I was not at all surprised the selection was unanimous. And, while this award may seem small in comparison to some, it represents heartfelt recognition

for everything Delta Dental of Oklahoma has done for the dental school and for the dental profession in Oklahoma."

Since its inception, the Delta Dental of Oklahoma Charitable Foundation has provided more than \$450,000 in funding for the OU College of Dentistry and its related initiatives. Those include:

- Establishing the Delta Dental of Oklahoma Distance Learning Center (DLC)
- Establishing the Bartlesville Clinic (in conjunction with the DLC)
- Establishing a \$25,000 Delta Dental of Oklahoma Annual Scholarship Fund
- Supporting the Good Shepherd Dental Clinic

Delta Dental is the second recipient of this annual award which was created last year by the OUCOD Alumni Association to recognize non-alumni for their contributions to dentistry. The inaugural (2006) recipient of this award was the University Hospitals Authority and Trust.

# News & Updates

## We Need Your NPI!

The NPI compliance deadline has passed. If you want to prevent possible claims processing problems, please obtain your NPI now, it is quick and simple. The application takes about 20 minutes to complete. To apply online, log on to nppes.cms.hhs.gov or call 1-800-465-3203. Once you have obtained your NPI number, please send DDOK a copy of the actual verification/confirmation form you received from NPPES. You may fax the information to 405-607-2149 or email ccorbin@deltadentalok.org. If you need another copy of the verification/confirmation form, please call 1-800-465-3203.

## Important NPI Update

- A single dentist filing business taxes under a TIN and not a Social Security Number is required to obtain a Type 2 NPI number in addition to the Type 1 NPI.
- A single dentist filing business taxes under a personal Social Security Number requires a Type 1 NPI number and is not eligible for a Type 2 NPI number.
- In a group practice, each dentist is required to obtain an individual Type 1 NPI number. The group practice that files under a TIN will need its own separate Type 2 NPI number.
  - \*Based on the above guidelines established by the NPPES Department, Delta Dental of Oklahoma requires a Type 2 NPI for all dentists/practices filing business taxes with a TIN.

## Meet Chastity Corbin: Provider Service Representative



In December 2002, Chastity Corbin was named Provider Service Representative for Delta Dental of Oklahoma. She is responsible for updating

and maintaining all Oklahoma provider information on a local and national level. She serves as the National Provider File (NPF) Coordinator for DDOK.

Chastity works closely with Delta Dental Plans across the country to insure they are using the most current provider information to process Oklahoma dentist's claims. She also manages dentist enrollment for direct deposit and provides customer service for direct deposit inquiries. Additionally, Chastity serves on the National Provider Identifier (NPI) team working to insure all systems are prepared when the NPI mandates are put in place.

Chastity has been part of the Delta Dental

of Oklahoma team for almost ten years. She joined the Customer Service Department at Delta Dental of Oklahoma as a Customer Service Representative. She later worked as a Claims Processor and Orthodontic Claims Auditor - responsible for processing all international claims and resolving provider issues related to claims.
