### Neighbor for Neighbor announces new dental coordinator

Neighbor for Neighbor is proud to announce the appointment of Cheryl Brewer to the position of dental coordinator of the NFN Dental Clinic. In this article, NFN Executive Director Ann Smith shares Cheryl's amazing success story.

When Cheryl was 6 years old her parents divorced. By the time she was 12 years old, her single mother was working three jobs and her slightly older sister was basically raising her. Without a good support system, the door was open for trouble. Crisis after crisis followed in her adult life, culminating when her 15 year old son died of leukemia and her 19 year old son died of a sudden brain aneurism soon after. These painful experiences

turned Cheryl toward an addictive life which dead-ended with incarceration.

In her darkest hours while incarcerated, she cried out to God begging for help. One of her continuous prayers was to have her teeth fixed. She had lost and damaged her front teeth and knew it would be hard to get a job without some dental care and restoration. After incarceration, she heard about the Neighbor for Neighbor dental program. She was able get an appointment at NFN with volunteer dentist Dr. Bruce Stewart, who restored her teeth. Dr. Stewart invited her to NFN for training to become a dental assistant.

With the blessing of this advanced training and experience from Dr. Stewart, Cheryl went on to get a job in the office of Tulsa dentist Dr. Joe Massad. For the next four years, she obtained additional training and experience as a dental assistant and patient care specialist in Dr. Massad's office. During this time, Cheryl continued to volunteer at the NFN Dental Clinic and was eventually hired to work evenings.

In April 2010, Cheryl was offered and accepted the position of NFN Dental Coordinator.

Cheryl is a remarkable role model for other NFN patients and clients. Neighbor for Neighbor is blessed to have her as NFN Dental Coordinator.

Neighbor for Neighbor has been a Delta Dental of Oklahoma Charitable Foundation grant recipient for eight years.
