


Foundation to Launch New Online Grant Application

RAM Oklahoma Event Seeks Volunteers for August Clinic

The second Remote Area Medical (RAM) Oklahoma event is scheduled for Saturday, Aug. 25, and Sunday, Aug. 26 at the Oklahoma State Fairgrounds in Oklahoma City. The event will provide dental, medical and vision services free of charge to hundreds of underserved Oklahomans on a first-come, first-served basis.



In 2010, RAM delivered 2,497 services to 1,635 individual patients at its Oklahoma event. More than 900 patients received dental care, which was the most requested service. Volunteers of all kinds are needed but because dental care is again expected to be in high demand, RAM Oklahoma is especially seeking volunteer dental professionals and students to staff the event's 50 mobile dental operatories. Volunteer times are flexible and volunteers will be provided with all necessary equipment and meals.

"Like Mission of Mercy, this RAM event is an opportunity for hundreds of Oklahomans to gain access to important dental care they otherwise couldn't afford," said John Gladden, president and CEO of Delta Dental of Oklahoma. "And, as with OkMOM, it will only be made possible by dentists, hygienists, assistants, and students generously volunteering their time. We are proud to support the efforts of these volunteer dental professionals as a lead sponsor of the event, and encourage volunteers to register as soon as possible."

DDOK Proposes Enhancements for Mission of Mercy (MOM) Patient Waiting Experience

For the past three years Delta Dental of Oklahoma (DDOK) has enjoyed its collaboration with the Oklahoma Dental Association and Oklahoma Dental Foundation to host Dental Mission of Mercy events in Oklahoma. In addition to Oklahoma, MOM events are held annually in numerous states and offer free dental care to those who otherwise would not be able to afford it. Recently, DDOK elected to explore the experience of patients waiting overnight for MOM treatment and is proposing ideas to improve the waiting patients' experiences and enhance their health, safety and comfort.

At MOM events around the country, it is common for patients to line up several hours before the doors open, and many patients even wait outside overnight to ensure they will receive care. DDOK President and CEO John Gladden recently traveled to Jonesboro, Ark., and spent the night interviewing and observing patients waiting in line to analyze line formation and dynamics prior to the doors opening for the Arkansas Mission of Mercy.

Mr. Gladden prepared a white paper entitled for the national MOM organization documenting his observations and recommendations entitled "Camping for Care." The paper can be viewed at www.tinyurl.com/campingforcare.

"We care a great deal about Mission of Mercy patients and their safety, welfare and comfort," said Gladden. "There are many fairly simple things that can have a positive impact on these patients' experiences waiting in line. We hope that what DDOK does will become a national standard for all MOM events and that other Delta Dental plans will adopt these practices for their events."

Linda Boykin Receives Distinguished Service Award

Linda leads by example as an active member and past president of the ODAA and an influential representative to the American Dental Assistants Association.

Linda received a plaque and a prize package of items to help facilitate her educational outreach and volunteer work including a \$200 gift certificate to Practicon, 200 Captain Supertooth brush charts and 200 toothbrushes.

The Foundation plans to present a distinguished service award to an outstanding dental hygienist later this year.
